3. PROFILE OF SKILLS AND COMPETENCES

Core task 1: Draws up and/or assists in the preparation of event plans

- 1.1 Assesses wishes and requirements of the client
- 1.2 Collects and analyses information for events
- 1.3 Prepares a risk analysis and overview of the necessary permits
- 1.4 Draws up and/or adjusts proposals for event plans
- 1.5 Elaborates and presents event plans
- 1.6 Prepares budgets and quotations for the client

Core task 2: Organises events and event promotion

- 2.1 Elaborates a scenario and call sheet
- 2.2 Organises event promotion
- 2.3 Organises the rental/purchase of materials, people, technical equipment, (virtual) spaces, catering, transport and facilities
- 2.4 Responsible for the administration for participants
- 2.5 Arranges the event infrastructure
- 2.6 Arranges the layout of rooms, installation materials and equipment and all facilities
- 2.7 Arranges the security organisation for the event

Core task 3: Supports in the implementation of the event

- 3.1 Monitors progress during the event
- 3.2 Coordinates the sale/rental of products, catering and additional services
- 3.3 Coordinates the reception of visitors, artists, suppliers and subcontractors
- 3.4 Informs and advises those present, and deals with complaints

Core task 4: Winds up the event

- 4.1 Deals with financial, staffing and administrative issues relating to events
- 4.2 Evaluates the event and submits improvement proposals

The Event organisation worker works in a wide variety of sectors and industries (profit, not-for-profit, government, event, music & entertainment industry, etc.) both online and offline.

International agreements Event organisation worker is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.	
Average duration of the education/ training leading to the certificate	3 years (4800 study hours) (depending on previous education)
Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl , only in Dutch. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate. Additional information, including a description of the Dutch national qualifications system, is available at the Netherlands National Reference Point (NRP): www.s-bb.nl . The NRP is the information centre for vocational qualifications in the Netherlands. SBB has been appointed in this capacity by the Ministry of Education, Culture and Science.
