3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Commercial assistant fashion are:

Core task 1: Assesses and monitors the product development

- 1.1 Assesses collection items for technical production quality
- 1.2 Advises those involved about adjustments to collection items
- 1.3 Monitors production specifications and technical drawings
- 1.4 Assesses raw materials and accessories
- 1.5 Monitors the sample planning
- 1.6 Assesses the samples

Core task 2: Gathers information about the sale of the collection

- 2.1 Gathers together sales data
- 2.2 Assesses and reports about the sales data
- 2.3 Cancels (parts of) orders

Core task 3: Assesses and monitors the production

- 3.1 Monitors the production process
- 3.2 Solves production problems in consultation with other departments
- 3.3 Registers and gains information about current orders
- 3.4 Inspects the finished product
- 3.5 Passes the production samples

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Commercial assistant fashion is qualified to work in the clothing industry in various departments of a (integrated) clothing company, a wholesale trade, or a retail trade organization, such as the department of production supervision, the department of production preparation, and the department of ready product purchase.

<p>Access to next level of education/professions In a company the Commercial assistant fashion can develop into production manager. The production manager manages the production department and is generally a member of the board. After achieving this qualification, a Commercial assistant fashion can develop through a higher professional education related to management in branches such as fashion or textile.</p>	<p>International agreements The profession of Commercial assistant fashion is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93781 The education and training for this qualification is offered as of August 1, 2011.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>4 years (6400 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
