3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Maritime officer all ships are:

Core task 1: Navigation

- 1.1 Makes up travel preparations
- 1.2 Keeps the navigation watch
- 1.3 Manoeuvres the boat and reacts to nautical emergencies

Core task 2: Cargo handling and stowage

2.1 Is responsible for the loading, transport and unloading of the cargo

Core task 3: Controlling the operations of the ship and care for persons on board

- 3.1 Is responsible for the safety and compliance with environmental and legal requirements
- 3.2 Is responsible for the seaworthiness of the boat

Core task 4: Marine engineering

- 4.1 Uses tools and apparatus in the machine room
- 4.2 Keeps the machine room watch
- 4.3 Operates main and assistant work vessels

Core task 5: Electrical, electronic and control engineering

5.1 Operates and maintains electrical and electronic systems on board

Core task 6: Maintenance and repair

6.1 Coordinates and carries out maintenance on the technical workings

Core task 7: Safety

- 7.1 Identifies and deals with calamities and accidents on board
- 7.2 Manages and is in charge of life-saving vessels during launching and afterwards
- 7.3 Provides medical assistance in case of accidents and medical care for the sick
- 7.4 Organises fire-fighting operations on board
- 7.5 Carries out maritime communication

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Maritime officer all ships works in an international professional environment. He sails on ships that sail both in short sea and worldwide, for instance in general cargo or bulk transportation, container transport, refrigerated transport, tanker traffic, sea towage, heavy cargo, and the ferry and passenger sector.

Access to next level of education/professions Having completed this course of studies, transfer is pos- sible to higher professional education. The Maritime officer all ships starts as an officer with authority and after a certain sailing time and if proven competent, can attain the final position of captain and/or chief engineer for all ships. This entails managing other ship's officers and the other crew members. Legal basis	International agreements The profession of Maritime officer all ships is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

The education and training for this qualification is offered as of August 1, 2009.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
