## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Sales advisor home furnishing are:

Core task 1: Is responsible for the receipt and processing of goods

- 1.1 Builds up and takes care of article presentations
- 1.2 Inspects the stock and orders (or suggests what to order)
- 1.3 Takes care of sales area and/or storage area

Core task 2: Sells, gives advice and service

- 2.1 Supervises colleagues in their sales activities
- 2.2 Receives and addresses clients
- 2.3 Carries out sales and advisory consultations
- 2.4 Supplies made-to-measure work specific to the sector
- 2.5 Negotiates with the client within the framework of the business
- 2.6 Places an order on behalf of a client
- 2.7 Makes up quotations
- 2.8 Takes complaints and/or deals with complaints

Core task 3: Conducts and/or completes sales transactions

- 3.1 Makes up a sales order
- 3.2 Completes orders

Core task 4: Optimises sales and assortment

- 4.1 Suggests improvements concerning the assortment
- 4.2 Suggests improvements concerning the presentations
- 4.3 Analyses the sales figures and makes suggestions for improvements
- 4.4 Takes part in work meetings

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Sales advisor home furnishing works in the retail or wholesale trade, within varying formulas, in both SMEs and in chain stores and in both the food and the non-food sector.

<p><b>Access to next level of education/professions</b> With the certificate of Sales advisor home furnishing, transfer is possible to a middle management or specialist course (qualification level 4).  Career opportunities for the Sales advisor home furnishing within the intermediate vocational education and on the job market within the retail and wholesale trade are: - Trade manager (e.g.: Department manager, Branch manager, Branch manager wholesale business and Manager household goods), level 4; - Entrepreneur retail trade level 4. In addition, he can enter the programme for Interior advisor level 4.</p>	<p><b>International agreements</b> The profession of Sales advisor home furnishing is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 90381 The education and training for this qualification is offered as of August 1, 2009.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
