- 1.6 Cleans and disinfects workplaces and materials

Core task 2: Receives and processes goods

- 2.1 Is responsible for stock
- 2.2 Orders goods
- 2.3 Carries out inspection of delivered goods on arrival
- 2.4 Stores away the goods

Core task 3: Produces fresh products

- 3.1 Prepares for production
- 3.2 Processes meat
- 3.3 Processes product according to the recipe
- 3.4 Packages products

Core task 4: Supervises the colleagues

- 4.1 Manages sales and/or production workers
- 4.2 Supervises sales and/or production workers

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Butcher is qualified to carry out works in the fresh produce sector, i.e. at a real butcher's, a sausage processing plant, the supermarket, the fishmonger's, or a butcher's van.

<p><b>Access to next level of education/professions</b> With the certificate of Butcher, transfer is possible to a middle management or specialist course (qualification level 4).  After obtaining the qualification of Butcher, the participant within the retail trade can rise to manager or entrepreneur in a fresh food shop or supermarket.</p>	<p><b>International agreements</b> The profession of Butcher is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 91633 The education and training for this qualification is offered as of August 1, 2009.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
