3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Construction repair specialist are:

Core task 1: Carries out maintenance, and/or repairs and/or modifications on aeroplanes, aeroplane systems and/or components

- 1.1 Does preparatory work for maintenance and/or repair and/or modification
- 1.2 Carries out disassembly and assembly work
- 1.3 Performs repairs and/or modifications
- 1.4 Carries out controls and tests
- 1.5 Completes maintenance and/or repair and/or modification

Core task 2: Produces parts and components of metal or composition metal for repairs and modifications

- 2.1 Prepares own working duties
- 2.2 Makes machines and tools ready for use
- 2.3 Adapts and processes plate and synthetic material and composite
- 2.4 Performs checks and measurements on plating and synthetic material and composite
- 2.5 Rounds off working duties

Core task 3: Give functional supervision

- 3.1 Takes part in the team meetings
- 3.2 Supervises employees in the implementation of the work
- 3.3 Check results of the work and completes the work

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Construction repair specialist is primarily employed by so-called EASA Part 145 companies, part M sub part F, which involves maintenance on aeroplanes. This includes amongst others airline companies, defence and Maintenance Repair Overhaul organisations (MRO) for aeroplanes, aeroplane systems and/or components. The Construction repair specialist carries out both line maintenance and major maintenance. He is within his level

<p>Access to next level of education/professions The Construction repair specialist can be transferred to construction repair specialist plastics, to construction repair specialist metal or the other way round, or to be transferred to skilled mechanic aircraft maintenance.</p>	<p>International agreements The profession of Construction repair specialist is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
