Core task 3: Carries out small adjustments to mass-produced footwear

- 3.1 Makes appointments with the client
- 3.2 Carries out adjustments to the inner sole, foot bed or uppers
- 3.3 Has adjustments carried out to the soles

Core task 4: Provides professional skills for the benefit of their business

- 4.1 Starts up a shoe shop
- 4.2 Gives form to a shoe shop
- 4.3 Analyses the market
- 4.4 Promotes and profiles a shoe shop
- 4.5 Innovates a shoe shop
- 4.6 Forms and participates in a network
- 4.7 Determines the sales prices and tariffs
- 4.8 Buys in materials

The range of tasks also includes drafting new procedures.

### Access to next level of education/professions

The Footwear consultant/entrepreneur can develop into self-employed entrepreneur. He can choose to start his own business, or move on up to the position of business manager/branch manager. If the Footwear consultant/entrepreneur wishes to continue to grow, he can do additional training in the field of podology, podopostoral therapy, and orthopaedic footwear technology.

# International agreements

The profession of Footwear consultant/entrepreneur is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC. amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

### Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94682 The education and training for this qualification is offered as of August 1, 2009.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

### Average duration of the education/ training leading to the certificate

3.5 year(s) (5600 study hours) (depending on previous education)

### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
