- 2.3 Instructs and coaches
- 2.4 Assesses and monitors improvements

Core task 3: Carries out practical working duties as project leader

- 3.1 Prepares the project
- 3.2 Manages colleagues
- 3.3 Monitors quality and progress of project
- 3.4 Delivers the project

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Journeyman painter - junior foreman mostly works in employment in the painting and maintenance sector. He works for various clients within the sectors house building, utility construction, renovation/conversion, new construction, and the result-oriented real estate maintenance.

<p><b>Access to next level of education/professions</b> The Journeyman painter - junior foreman can rise to a middle management position (e.g., operator, entrepreneur) or to a specialist position. The most logical position for a Journeyman painter - junior foreman is in middle management. This is possible via the programme for Supervisor building completion and maintenance (level 4).</p>	<p><b>International agreements</b> The profession of Journeyman painter - junior foreman is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 91461 The education and training for this qualification is offered as of August 1, 2009.</p>																					

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>4 year(s) (6400 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
