#### PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Adaptation technician are:

Core task 1: Repairs, maintains and makes standard rehabilitation aids ready for delivery

- 1.1 Goes through work order card for standard working duties
- 1.2 Maintains and repairs a standard aid
- 1.3 Installs parts to a standard aid
- 1.4 Adjusts a standard aid to the measurements of the end user
- 1.5 Carries out final control on a standard aid
- 1.6 Administrates working duties concerning a standard aid

Core task 2: Delivers standard rehabilitation aids and instructs end user

- 2.1 Adjusts a standard aid to the end user
- 2.2 Instructs the end user
- 2.3 Adjusts a standard aid
- 2.4 Hands over a standard aid to the end user

Core task 3: Investigates technical complaints and carries out complex maintenance and repairs to rehabilitation aids

- 3.1 Goes through work order card with complex working duties
- 3.2 Maintains and repairs a complex aid
- 3.3 Diagnoses technical complaints of a complex aid
- 3.4 Rectifies technical complaints of a complex aid
- 3.5 Administrates working duties concerning a complex aid

Core task 4: Develops adaptions and individual adjustments to rehabilitation aids, makes these ready for delivery and delivers them

- 4.1 Designs adaptions or individual adjustments
- 4.2 Supports the adaption advisor
- 4.3 Builds and/or adjusts rehabilitation aids
- Adjusts a rehabilitation aid to the measurements of the end user
- Administrates working duties on rehabilitation aids
- Adjusts rehabilitation aids on delivery

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Adaptatation technician works in a working environment with aspects of the technology and health care sector. The Adaptatation technician works in a rehabilitation technical company or in a rehabilitation centre where a disability (a handicap) of the client is reason to call in the company.

#### Name and status of the body awarding the certificate Name and status of the national/regional authority The certificate issued on completion of the programme is providing accreditation/recognition of the certificate signed by the examination board at the school where the Ministry of Education, Culture and Science pupil attended the programme.

## Level of the certificate (national or international)

Qualification level 3 of the Dutch VET qualification

Characteristics: implementation of more than just the own block of tasks. The professional is able to account for his or her actions towards colleagues, and monitors and supervises the work of others. The range of tasks also includes drafting work preparation procedures. NLQF level 3 - EQF level 3 - ISCED 3C

#### Access to next level of education/professions

After obtaining the certificate Adaptation technician (level 3), promotion to Adaptation advisor (level 4) is possible for the professional.

#### International agreements

The profession of Adapatation technician is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

#### Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93670 The education and training for this qualification is offered as of August 1, 2009.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

#### Average duration of the education/ training leading to the certificate

3 year(s (4800 study hours) (depending on previous education)

#### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
