The Specialist logistics and quality works, for instance, for a whole sale company, production company or transport company that occupies itself with trade, transport, sampling and preparing agricultural food products for an auction.

<b>Access to next level of education/professions</b> The Specialist logistics and quality Specialist can specialise during his career in a certain product group (such as flowers, fruit, plants) or a department of the wholesale company (such as procurement or logistics). It is possible to switch to the position of business manager or self-employed entrepreneur in another sector, both inside and outside the domain of food and living environment.	<b>International agreements</b> The profession of Specialist logistics and quality is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.														
<b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 97762 The education and training for this qualification is offered as of August 1, 2011.															

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<b>Average duration of the education/ training leading to the certificate</b>	<b>4 years (6400 study hours) (depending on previous education)</b>
<b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
