4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Specialist textiles works in companies which belong to the fibre processing, yarn processing and textile finishing. Depending on the company he works for, he carries out actions on machines to spin, to fleece manufacturing, razor, twine, weave, knit, tuft, pretreating, dye, print or finish.

<p>Access to next level of education/professions On the basis of education and/or training transfer is possible. Depending on the personal interest, capacities and experience, it is possible for the Specialist textiles to grow into a position at level 4 in the manufacturing sector/process industry/food industry. Besides, it is possible to transfer to another sector within the process industry. For the Specialist textiles, a team leader is most conventional promotion prospect within both education and career.</p>	<p>International agreements The profession of Specialist textiles is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
