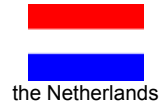

The Machine operator earth-moving carries out earth-moving work with earth-moving machines, including hoisting related to earth-moving.</p> |

| <p>Access to next level of education/professions A Machine operator earth-moving can develop through middle management educations within this sector and through VET-level 4 educations within this qualification structure, such as qualifications in Supervision construction & infrastructure or Planning/implementation. After receiving additional education and indicating required skills, it is possible for the Machine operator earth-moving to develop further administrative and organisational positions, such as co-supervisor, planner or building site supervisor. It is also possible for the Machine operator earth-moving to develop horizontally in the labour market. For example, he could operate other machinery or become a mechanic.</p> | <p>International agreements The profession of Machine operator earth-moving is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. | 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE | |

| <p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p> | |

| <p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p> | |

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
