3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Security officer are:

- preventive surveillance;
- entrance security;
- surveillance from a watch post;
- helping people in need, and attempting to maintain order, peace and safety;
- surveillance in offices, houses and industrial or business parks;
- identifying and reporting on unusual situations:
- reporting unusual circumstances or situations to a central control post;
- determining when an alarm should be sounded, or other intervention should be undertaken;
- if necessary, calling the police, fire brigade or ambulance service;
- detaining or accosting individuals violating rules or regulations;
- report on the proceeding of actions undertaken.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Depending on their specialisation, they work as security officers for major events, individuals, money and valuable property transport, in parking management or in an alarm centre. Security officers work either in company security organizations or are employed by private security companies that, in turn, deploy them at their clients' premises.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
