3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Stage and event technician - sound are:

Core task 1: Assembles and disassembles production

- 1.3 Moves machines around using internal means of transport
- 1.4 Builds up production or event location and takes it down again
- 1.5 Places and uses props during performances
- 1.6 Solves technical building and removal problems

Core task 2: Installs and operates apparatus

- 2.1 Consults with the client
- 2.2 Lays cables
- 2.3 Places light, sound and image apparatus (hanging up and connecting)
- 2.4 Operates light, sound and image apparatus
- 2.5 Provides special effects
- 2.6 Solves technical installation and operational problems
- 2.7 Maintains apparatus
- 2.8 Connects sound apparatus
- 2.9 Applies sound techniques and effects
- 2.10 Improves the acoustics
- 2.11 Makes sound recordings
- 2.12 Carries out audio processes

Core task 3: Organises production technology

- 3.1 Advises client about technical possibilities concerning a production
- 3.2 Consults with the client
- 3.3 Controls technical working duties during a production
- 3.4 Solves technical problems which arise
- 3.5 Carries out investigation of location
- 3.6 Manages the production budget
- 3.7 Organises users' rights

<p>Access to next level of education/professions Doing a higher vocational education is possible. In the field of theatrical technology, the only possible specialization is via the Theaterschool Amsterdam, programme for Technology & theatre. In the field of audiovisual technology or logistics, there are several courses to connect to the level of higher vocational education.</p>	<p>International agreements The profession of Stage and event technician - sound is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
