3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Biotechnician are:

Core task 4: Coordinates working duties

- 4.1 Plans and organises working duties
- 4.2 Instructs and supervises employees, interns and students
- 4.3 Gives information and educates

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Biotechnician is employed with a licenced company or institution, regarding the *Wet op dierproeven* (The Experience on Animals Act) where animal testing is carried out and where laboratory animals are accommodated and/or bred. This could be an animal laboratory associated with a university or hospital, a commercial institution,

Access to next level of education/professions Many Bio technicians ultimately specialise internally in carrying out several bio technical actions, such as specialist breed anaesthesia, specialist anaesthesia (large) animals. It is also possible for a Bio technician to specialise in the role of trainer or flow through to a higher level (management, unit leader or team leader, or hbo-position).	International agreements The profession of Biotechnician is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95370 The education and training for this qualification is offered as of August 1, 2011.	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).
 In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.
 In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
