- 2.3 Makes calculations
- 2.4 Makes up quotations
- 2.5 Makes recalculations

Core task 3: Purchases

- 3.1 Prepares purchase or other orders
- 3.2 Realises purchases or other orders
- 3.3 Monitors the purchase and delivery processes

The Planner wood trade (level 4) works for companies in the furniture industry, wood assembly industry and wood trade.

5. OFFICIAL BASIS OF THE CERTIFICATE	
<p>Qualification level 4 of the Dutch VET qualification structure</p> <p>Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. <p>Access to next level of education/professions</p> <p>A diploma at level 4 gives access to higher vocational education. Technical higher vocational education programmes such as Technical business administration and Architecture are the most logical step.</p>	<p>International agreements</p> <p>The profession of Planner wood trade is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>
<p>Legal basis</p> <p>Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94653</p> <p>The education and training for this qualification is offered as of August 1, 2009.</p>	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>4 year(s) (6400 study hours) (depending on previous education)</p>
<p>Entry requirements</p> <p>The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
