3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Social pedagogical carer are:

Maintains a direct relationship with the day-to-day affairs in the living environment and focuses activities on both the individual and the group.

The Social pedagogical carer will provide educational supervision to the individual and the group in residential and living situations, whereby the self-reliance of the individual will be encouraged as far as possible. He draws up, implements and evaluates a supervision plan (personal plan). He will carry out the tasks on the basis of specific methods. He organises individual and group-oriented activities.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Social pedagogical carer carries out activities in a wide range of settings, in community, semi-residential and residential work forms. He works as a group leader, group worker or social care worker in: The care for the disabled in for example residential homes, day nurseries, social housing in institutions for care recipients with psychological problems, in remand prisons and other penitentiary institutions, in day centres, in institutions for the elderly and rehabilitation centres.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
