3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled worker recreational company are:

Core task 1: Performs maintenance work in nature and living environment

- 1.1 Maintains water (ponds)
- 1.2 Maintains surfacing
- 1.3 Keeps parks and gardens
- 1.4 Maintains buildings and provisions
- 1.5 Leaves work environment well-kept

Core task 2: Takes care of guests

- 2.1 Acts as host
- 2.2 Points out complaints and deals with them
- 2.3 Takes action in the case of calamities and accidents
- 2.4 Supports activities

Core task 3: Organizes and supervises work

- 3.1 Plans and spreads the work
- 3.2 Gives support in the technical field
- 3.3 Organizes materials and equipment

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled worker recreational company works for a job organization of the government, for a foundation, or he works in the private sector. He works in a forest and/or nature area, a rural area, in greenery, for a recreational company, a water board, for a contractor or for a landscaping firm.

<p>Qualification level 3 of the Dutch VET qualification structure</p> <p>Characteristics: implementation of more than just the own block of tasks. The professional is able to account for his or her actions towards colleagues, and monitors and supervises the work of others. <p>Access to next level of education/professions</p> <p>After training and/or experience, the Skilled worker recreational company can be trained to Manager nature and recreation, Environment officer or Supervisor environment and open spaces.</p>	<p>International agreements</p> <p>The profession of Skilled worker recreational company is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>
<p>Legal basis</p> <p>Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 97255</p> <p>The education and training for this qualification is offered as of August 1, 2009.</p>	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>3 year(s) (4800 study hours) (depending on previous education)</p>
<p>Entry requirements</p> <p>The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
