3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled floristry worker are:

- Independently producing all requested flower work. This includes assembling and binding special bouquets according to a variety of techniques; producing flower work for special occasions.
- Using special wiring techniques.
- Designing and producing project flower work and planting.

As well as producing all requested flower work, the floristry worker is responsible for the shop layout and the product presentation, and has extensive product and specialist knowledge. He can purchase, prepare products for sale and carry out stock control. He sells and is able to deal with order administration and complaints. He has a commercial approach and acts accordingly.

As well as being involved with the technical aspects of the profession, he is often also a manager, in companies with up to 5 employees. This involves management of the other staff and responsibility for purchasing.

The Skilled floristry worker is responsible for his own set of tasks, tools and materials. He can take responsibility for staff placed under his management. He answers for his activities to the company owner/florist and senior manager, respectively.

International agreements The profession of Skilled floristry worker is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.	
Average duration of the education/ training leading to the certificate	2 years (3200 study hours) (depending on previous education)
Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
