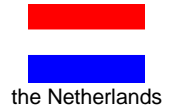

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Social worker operates at the heart of society and is employed in a variety of contexts in which people require individual and/or collective support to be able to function in their own living environment and participate in society. The Social worker stands side by side with the people he supports, visits them or receives them on location. The Social worker is employed within a variety of different fields of life and provides a service in respect of financing, accommodation and quality of life, work, education and activities, social interaction, physical and psychological health and spiritual wellbeing. The Social worker can be employed within organisations and institutions, and within collaborative organisations.

<p>Access to next level of education/professions The Social worker can develop through subsequent higher professional educations. Educations within reach of Social worker are for example: Social Work, Socio-pedagogic aid, Social Work and Service Provision, Cultural and Social Education and Pedagogy. After obtaining this qualification, transfer is possible to the following Associate Degree courses: Social Work, Social Financial Service Provision, Youth Work.</p>	<p>International agreements The profession of Social worker is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Adult and Vocational Education Act (WEB), registered number of qualification (crebo): 25615 The education and training for this qualification is offered as of August 1, 2020.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>3 years (4800 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
