- 2.2 Disassembles and assembles clocks and watches
- 2.3 Cleans and replaces parts
- 2.4 Carries out repairs to standard systems of clocks
- 2.5 Carries out repairs to more complex systems of clocks
- 2.6 Inspects functions and oils parts
- 2.7 Makes up the restoration report
- 2.8 Finishes off repair

Core task 3: Provides professional skills for the benefit of their business

- 3.1 Starts up a business
- 3.2 Gives form to the business
- 3.3 Innovates the business
- 3.4 Promotes and profiles the business
- 3.5 Participates in networks

### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

In the Netherlands, the clock technical sector mainly consists of businesses without any or with just a few staff members. Most of the Clockmakers own their own repair workshop, increasingly often in combination with a shop selling clocks. Independent Clockmakers work for private persons or jewellers who contract out repair work.

## Level of the certificate (national or international)

Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. # Access to next level of education/professions

After obtaining his diploma, the Clockmaker can focus on repairing or restoring the more complicated clocks. Doing specialized clock programmes is a possibility (for instance, Wostep). Another possibility is to enter higher vocational education programmes for precision engineering, as some programmes for mechanical engineering offer them.

## International agreements

The profession of Clockmaker is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

### Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 92922 The education and training for this qualification is offered as of August 1, 2009.

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

## Average duration of the education/ training leading to the certificate

4 year(s) (6400 study hours) (depending on previous education)

#### Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
