3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Stage and event technician - lighting are:

Core task 1: Organises production

- 1.1 Acquires assignments
- 1.2 Advises client about technical possibilities
- 1.3 Organises administrative and financial matters
- 1.4 Develops a plan for the production
- 1.5 Plans the working duties
- 1.6 Collects information on the production
- 1.7 Manages crew members

Core task 2: Technical preparation production

- 2.1 Coordinates the work
- 2.2 Gathers the necessary equipment and materials and makes them ready for use
- 2.3 Transports materials to the construction site
- 2.4 Sets up the production location and breaks it off
- 2.5 Places, hangs and connects light, sound and image apparatus (hanging up and connecting)
- 2.6 Keeps technical equipment and supplies operational
- 2.7 Adjusts light, display or sound apparatus
- 2.8 Does dry run with technical equipment for the benefit of production
- 2.9 Delivers installation

Core task 3: Realise production

- 3.1 Checks the operation of the installation and equipment
- 3.2 Operates light, sound and image apparatus
- 3.3 Actualises (floor) scene changes
- 3.4 Deals with disruptions

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Stage and event technician - lighting works for a large variety of organizations: theatres, playhouses, travelling companies, events, festivals, pop stage, rental companies of equipment or specialized temping agencies.

<p>Access to next level of education/professions Doing a higher vocational education is possible. In the field of theatrical technology, the only possible specialization is via the Theaterschool Amsterdam, programme for Technology & theatre. In the field of audiovisual technology or logistics, there are several courses to connect to the level of higher vocational education.</p>	<p>International agreements The profession of Stage and event technician - lighting is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
