3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Junior hairdresser are:

- 2.3 Blow-dries and styles
- 2.4 Temporary styling
- 2.5 Permanent styling
- 2.6 Sells and advises on products and services

Core task 3: (De)colouring hair

3.1 Analyses hair and scalp

- 3.2 Prepares and adjusts treatment plan and prepares treatment
- 3.3 (De)colouration

3.4 Completes treatment and updates administration

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Possible work environments for Junior hairdressers are: specialist ladies' salon, specialist gentlemen's salon, unisex hairdressing salon and specific hairdressing salon. The last type of hairdressing business targets a group sensitive to fashion and trends. The majority of hairdressers are unisex.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
