## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Window cleaner are:

Core task 1: Performs basic cleaning activities

- 3.1 Does preparatory work for basic cleaning activities
- 3.2 Carries out daily and periodic maintenance of interior spaces
- 3.3 Carries out periodical maintenance of sanitary ware
- 3.4 Performs periodic maintenance of soft floors
- 3.5 Performs periodic maintenance of hardwood floors
- 3.6 Completes the basic cleaning work

Core task 2: Carries out window cleaning

- 1.1 Prepares windows for cleaning
- 1.2 Cleans windows
- 1.3 Cleans windows at height
- 1.4 completes window cleaning

Core task 3: Carries out floor maintenance

- 2.1 Prepares floor maintenance
- 2.2 Carries out periodic maintenance of hard floors
- 2.3 completes floor maintenance

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Window cleaner works with a cleaning or window cleaning company, specialising in window cleaning mainly for buildings owned by private individuals and companies. He works at various locations, mostly outdoors but also regularly indoors.

Transfer to Specialist floor maintenance is the most obvious opportunity for advancement. The Window cleaner can also progress within the same level into the field of specialist cleaning, by following courses and on the basis of work experience.</p>	<p><b>International agreements</b></p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>2 years (3200 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
