3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled salesman are:

Core task 1: Takes care of processing of wares and store performance

- 1.1 Is responsible for receipt and storing away of goods
- 1.2 Cares for the shop presentation
- 1.3 Inspects the stock and suggests what to order
- 1.4 Carries out promotional activities with respect to (online) information systems

Core task 2: Optimises sales

- 2.1 Acts as host
- 2.2 Analyses the sales results and makes suggestions for improvements
- 2.3 Makes improvement proposals with regard to the market position in the local market
- 2.4 Handles (online) requests, orders and/or customer complaints
- 2.5 Takes part in and/or leads the team meetings

Core task 3: Carries out sales activities

- 3.1 Carries out sales consultations
- 3.2 Makes articles/customizes products or makes them ready-to-use
- 3.3 Completes the sale
- 3.4 Closes up the payment system and takes care of its administration

Core task 4: Manages a sales team

- 4.1 Makes work schedules
- 4.2 Manages activities
- 4.3 Makes improvement proposals with respect to the implementation of personnel management
- 4.4 Assists in the acquisition and selection of employees

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

In most cases the Skilled salesman works in a small or medium-sized enterprise or chain store within the nonfood sector. He usually works in a sales team under a manager or entrepreneur. This branch and specific function determine what is the most relevant in carrying out tasks.

The Skilles salesman is generally a co-foreman.

However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25153 The education and training for this qualification is offered as of August 1, 2015.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
