Core task 2: Manages the cross media workflow

- 2.1 Operates media control systems for the processing of cross media data
- 2.2 Processes media files for the processing of cross media data
- 2.3 Manages the storage of data to be used for cross media purposes
- 2.4 Implements and manages colour management systems
- 2.5 Manages complex content management systems

Core task 3: Facilitates the network use in media production surroundings

- 3.1 Designs a network in a media production environment
- 3.2 Realises a network in a media production environment
- 3.3 Manages the media software
- 3.4 Realises a network structure in a media production environment
- 3.5 Integrates multiple platforms in a network in a media production environment
- 3.6 Makes data connections between different items of network apparatus
- 3.7 Guards the networks in a media production environment

The Workflow manager can work for many types of companies within the media sector, such as advertising agencies, design & PR studios, multimedia companies, audiovisual companies, print media printers and publishers. Increasingly, he works for companies that develop games or game components.

<p><b>Access to next level of education/professions</b> The Workflow manager can do a relevant higher vocational education programme. Programmes available in this area are Media technology, IT media design, and Game development.</p>	<p><b>International agreements</b> The profession of Workflow manager is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 90613 The education and training for this qualification is offered as of August 1, 2009.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
