3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Logistic management worker - material management are:

Logistics describes the planning, implementation and management of the incoming and outgoing goods flows to/from a company, from the purchase of raw materials or parts from suppliers through to the distribution of the products to customers. Logistic management is the commercial function responsible for this task. Employees specifically involved in the processes of purchase, stock control and production planning are material management workers. The Logistic management worker - material management handles the management of goods flows, from raw materials through to a complete finished product. He also manages a stock of materials and maintains the relevant administrative records. He purchases and plans.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The log Logistic management worker - material management is employed within the wholesale sector in various formulae (including import, export, production). He may be employed in a range of food and non-food sectors, logistic service providers, production companies and transport companies.

5. OFFICIAL BASIS OF THE CERTIFICATE

With a diploma at qualification level 4, transfer is possible to higher professional education.

The profession of Logistic management worker - material management is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

4 years (6400 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
