The most important duties of a Skilled cultivation worker are:

- 1.2 Takes care of cultivation
- 1.3 Takes care of crop protection
- 1.4 Harvests crops
- 1.5 Processes harvest/product
- 1.6 Takes care of professional equipment/working environment
- 1.7 Prepares machines for use and carries out maintenance
- 1.8 Checks installations/equipment

Core task 2: Organising cultivation and labour

- 2.1 Plans and allocates tasks
- 2.2 Supervises colleagues (in technical professional areas)
- 2.3 Manages colleagues
- 2.4 Monitors progress of work
- 2.5 Monitors implementation of quality policy

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled cultivation worker works in a company of vegetable cultivation, bulb cultivation, potted plant cultivation, mushroom cultivation, cut flowers cultivation, agriculture, olericulture, bulb-growing cultivation, tree and plant cultivation, fruit cultivation or a combination of these cultivations. Depending on the type of cultivation, the Skilled cultivation worker works in indoor or outdoor cultivation.

Access to next level of education/professions Following qualification, the Skilled cultivation worker can transfer to the position of manager at a plant cultivation company, cultivation and cultivation technology specialist, cultivation and labour specialist and in individual cases, herbalist, on the basis of training and/or experience.	International agreements The profession of Skilled cultivation worker is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 97670 The education and training for this qualification is offered as of August 1, 2010.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
