The most important duties of a Medical pedicurist are:

- 3.5 Sells and gives advice about products and services
- 3.6 Evaluates and finishes off treatment

Core task 4: Runs a business

- 4.3 Develops the business policy
- 4.4 Profiles the business in the market
- 4.5 Carries to purchasing and stock policies
- 4.6 Determines tariffs and prices

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Medical pedicurists work in the personal care industry in the feet care sector. Medical pedicurists can work in the following environments: business at home, ambulatory, hospital, medical centre, or care institute. The most usual working environment is the business at home.

Access to next level of education/professions Horizontal and vertical promotion within the personal care industry to the qualifications of Beautician and Hairdresser is possible. Working as a training instructor is also a possibility. Furthermore, promotion is possible as a business manager, a management position, or self-employed entrepreneur.	International agreements The profession of Medical pedicurist is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94440 The education and training for this qualification is offered as of August 1, 2009.	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
