- 2.2 Processes harvest
- 2.3 Carries out simple repairs to machines, vehicles and apparatus

Core task 3: Organises and manages working duties

- 3.1 Formulates and monitors planning
- 3.2 Supervises colleagues in technical professional areas
- 3.3 Monitors implementation of quality policy

Core task 4: Maintains buildings, grounds and landscape elements

- 4.1 Maintains landscape elements
- 4.2 Maintains water courses and drainage
- 4.3 Maintains landscape elements
- 4.4 Carries out simple repairs to machines, vehicles and apparatus

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled worker outdoor cultivation works in the primary sector in the sector cultivation of plants. He works in a company with an outdoor cultivation. This sector includes agriculture, olericulture, bulb-growing cultivation, tree and plant cultivation and fruit cultivation.

However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>
