- 4.1 Prepares a service desk ready for use
- 4.2 Manages a service desk
- 4.3 Formulates users' instructions

ICT management is at play at ICT companies or at the ICT department of other companies. The ICT manager works in the ICT sector. Increasingly, the ICT manager will have to deal with links between various information systems.

<p>Access to next level of education/professions Based on work experience, the ICT manager can be promoted to a managerial position and after additional training to a position at the higher vocational education level. Within the higher vocational education, he can enter the programmes for Business information science, Information science, Technical information science, and Information services and management.</p>	<p>International agreements The profession of ICT manager is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93191 The education and training for this qualification is offered as of August 1, 2009.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
