- 3.2 Supervises and instructs colleagues

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

An Operator B can work in a diverse range of sectors within process industry. He can work at small, medium-sized and large companies which are part of the food & stimulant industry, carpet, textile & leather industry, paper industry, publishers & printing offices (graphics industry), petroleum industry, (bio)-chemical industry, pharmaceutical industry, rubber and synthetic industry, base metal industry, metal product industry, metallurgical industry, machine industry, electro-technical industry, transport industry, wood, furniture and miscellaneous industries.

<p>Access to next level of education/professions An Operator B can develop to a VET-level 4 position in the manufacturing, process or food industries. It is also possible to transfer to another sector within the process industry. The most accessible way to develop within education for an Operator B is Operator C.</p>	<p>International agreements The profession of Operator B is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25338 The education and training for this qualification is offered as of August 1, 2015.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
