PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Maritime officer fishing vessels SW5 are:

Core task 1: OL nautical A-II/1 (Carries out the nautical tasks at operational level A-II/1 on all fishing vessels)

- 1.1 Navigation at the operational level
- 1.2 Controlling the operation of the ship and care for persons on board at the operational level A-II/1

Core task 2: ML nautical A-II/2 (Carries out the nautical tasks at management level A-II/2 on all fishing vessels)

- 2.1 Navigation at the management level
- 2.2 Controlling the operation of the ship and care for persons on board at the management level A-II/2

Core task 3: OL technical A-III/1 (Carries out the technical tasks at operational level A-III/1 on all fishing vessels)

- 3.1 Marine engineering at the operational level
- 3.2 Electrical, electronic and control engineering at the operational level
- 3.3 Maintenance and repair at the operational level
- 3.4 Controlling the operation of the ship and care for persons on board at the operational level A-III/1

Core task 4: ML technical A-III/2 (Carries out the technical tasks at management level A-III/2 on all fishing vessels)

- 4.1 Marine engineering at the management level
- 4.2 Electrical, electronic and control engineering at the management level
- 4.3 Maintenance and repair at the management level
- 4.4 Controlling the operation of the ship and care for persons on board at the management level A-III/2

Core task 5: Carries out safety tasks (on fishing vessels)

- 5.1 Prepares to act in times of calamities and accidents
- 5.2 Provides limited first aid in case of accidents and medical care in the event of sickness on board
- 5.3 Carries out maritime communication

Core task 6: Catches and processes fish

- 6.1 Prepares the fishing
- 6.2 Monitors the fishing process
- 6.3 Carries out the operational activities for the sake of the fishing process
- 6.4 Keeps fishing materials, fishing aids and finishing installations operational

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Maritime officer fishing vessels SW5 (from now on indicated as Maritime officer) is primarily employed in the Cotter fishing industry but also in a lower position in the trawler fishing industry. The diploma Deck officer and engineer class V fishing fleet is coupled with a certification for seafarer, granted by the Minister of Infrastructure and Environment. This certification makes the following positions possible: SW 5 degree (+Marcom A) + radar navigator (Management level) + 3 years sailing time: skipper sea fishing for a fishing vessel <60 meter, capacity<3000 kW, unlimited sailing areas. Just as the SW 5 degree (+Marcom A + radar observer (operational level) + 1 year sailing time includes: deputy skipper sea fishing for a fishing vessel <60 meter, unlimited sailing areas, including the positions which come with lower degrees or less strict navigation time requirements, just like the positions belonging to lower degrees or less strict navigation time requirements.

Access to next level of education/professions

The Maritime officer small fishing vessels can rise to the position of cutter engine operator, cutter helmsman, or cutter captain. Obtaining additional certificates and navigation licences may be required for this. In due course, he may become captain. On the basis of obtained qualification Maritime officer fishing vessels SW5 at level 3, he can make a vertical transfer to the course Deck officer all fishing vessels S4 or the course Engineer all fishing vessels restricted operation area or the course Engineer all fishing vessels W4 at level 4.

International agreements

The profession of Maritime officer fishing vessels SW5 is regulated in the Netherlands under the European directive 2005/36/EC, amended by directive 2013/55/EU.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95738 The education and training for this qualification is offered as of August 1, 2012.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

3 years (4800 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
