3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Heating mechanic are:

- Assembly of heating installations and the setting and maintenance of heating installations. This includes the gas and water installations that form part of a central heating installation.
- Installing and setting air conditioning equipment.

The work is undertaken independently, and instruction may be issued to (assistant) engineers.

A candidate qualifies for the certificate after having gained the following modular qualifications:

- Installing heating installations;
- Social cultural changes;
- Work and society.

5. OFFICIAL BASIS OF THE CERTIFICATE

With a diploma at qualification level 3, transfer is possible to a course at qualification level 4.

The profession of Heating mechanic is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
