- 1.3 Makes a plan concerning lay-out, maintenance and/or management
- 1.4 Presents a plan concerning lay-out, maintenance and/or management

Core task 2: Is responsible for the implementation of work in nature and living environment

- 2.1 Formulates work plan
- 2.2 Delivers the work
- 2.3 Organises people, materials and means
- 2.4 Formulates and monitors planning
- 2.5 Supervises colleagues in technical professional areas
- 2.6 Is responsible for providing information and the development of staff
- 2.7 Monitors the performance budget
- 2.8 Monitors the performance of the policy on quality
- 2.9 Carries out acquisition
- 2.10 Carries out working duties

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Manager nature and recreation works for a job organization of the government, for a foundation or he works in the private sector. He works in a forest and/or nature area, a rural area, in greenery, for a recreational company, a water board, for a contractor or for a landscaping firm.

<p><b>Access to next level of education/professions</b> Career opportunities are found in the positions of, for instance, senior project leader, team leader, sector manager, department head, planning officer and calculator.</p>	<p><b>International agreements</b> The profession of Manager nature and recreation is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 97090 The education and training for this qualification is offered as of August 1, 2009.</p>																					

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
