Core task 2: Supervises the production process

- 2.2 Supporting production employees
- 2.3 Consulting with other disciplines
- 2.4 Carrying out project leader tasks
- 2.5 Optimizing the production process
- 2.6 Keeping records of and archiving production data

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Draughtsman planner works in the planning and control department of a company that develops technical products and produces those in a workshop. The company is active in one or a selection of the following work areas: metal industry; machine construction; transport vehicle industry; mechatronics; electronics/automation; climate control technology; information and communication; measurement and control technique; refrigeration technique; insulation technique.

## 5. OFFICIAL BASIS OF THE CERTIFICATE

**Name and status of the body awarding the certificate**

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

<b>Access to next level of education/professions</b> The Draughtsman planner can develop into designer/project leader (Associate degree: Mechanical engineering, Electro technology, Installation technology, Industrial product design or Technological economics). He/she can also transfer to hbo, to which he/she has access with the level 4 certificate. Depending on the context of his work, he/she can choose for technical/physics hbo programmes, such as Mechanical engineering, Electro technology, Technical economics and Industrial product design. The Draughtsman planner can develop into Draughtsman designer or Production planner.	<b>International agreements</b> The profession of Draughtsman planner is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.	
<b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 92514 The education and training for this qualification is offered as of August 1, 2008.		

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

<b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
