- 1.7 Carries out clearing up working duties

Core task 2: Installs sign material

- 2.1 Carries out transport working duties
- 2.2 Prepares the assembly
- 2.3 Assembles in place sign (part) products
- 2.4 Delivers finished product
- 2.5 Carries out clearing up working duties

Core task 3: Makes a design

- 3.1 Formulates plan of approach
- 3.2 Makes a design
- 3.3 Delivers the design

#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round sign maker works in employment or is self-employed in a service providing company in the sign and/or engraving sector. In addition, he can also work in stand building or in the in store sector.

<b>Name and status of the body awarding the certificate</b> The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.	<b>Name and status of the national/regional authority providing accreditation/recognition of the certificate</b> Ministry of Education, Culture and Science
<b>Level of the certificate (national or international)</b> Qualification level 3 of the Dutch VET qualification structure Characteristics: implementation of more than just the own block of tasks. The professional is able to account for his or her actions towards colleagues, and monitors and supervises the work of others. The range of tasks also includes drafting work preparation procedures. <b>Access to next level of education/professions</b> After education, the All-round sign maker can rise to sign specialist level 4. In addition, he can do a level 4 programme in this field (Spatial presentation and communication design or Media designer). In medium-sized and large companies, the All-round sign maker can rise to the function of project leader, business manager, or department head.	<b>International agreements</b> The profession of All-round sign maker is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
<b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94510 The education and training for this qualification is offered as of August 1, 2009.	

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
