## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled worker animal care are:

Taking care of the animals, when they are healthy as well as they are sick. A Skilled worker animal care cleans pens, stables, cages and instruments, works with devices and machines, prepares animals for a check-up by the veterinary surgeon, gives medicine and trims dogs. Besides looking after the animals, dealing with customers (reception, information and in some cases coaching) is very important. With that you must think of possessors of animals, buyers, volunteers and special groups of public (for example the handicapped persons).

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Skilled worker animal care can be working in a petshop, in an animal home, at a zoo and at a children's farm. Furthermore he can be working with laboratory animals and in a veterinary surgeon practice.

#### 5. OFFICIAL BASIS OF THE CERTIFICATE

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

**Average duration of the education/ training leading to the certificate**

**3 years (4800 study hours) (depending on previous education)**

##### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
