The most important duties of a Machinist are:

- Making products from various types of steel and cast iron, plus non-ferrous metals and synthetic materials, by reference to working drawings, sketches or in accordance with verbal instructions;
- Making products on small to medium-sized engine lathes and universal milling machines, making use of the associated equipment and the appropriate tools and resources.

Working as a Machinist in:

- a machine factory;
- a maintenance workshop;
- technical services at an industrial company.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
