## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Bartender are:

- looking after, advising and entertaining guests;
- ensuring the safety and well-being of guests during their stay;
- preparing and serving of drinks and small snacks;
- executing simple administrative tasks.

The tasks and techniques performed by the Bartender may be applied in a wide range of professional situations within the hospitality and catering business.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Bartender performs his tasks mainly in the domestic and international hotel and restaurant business and in cafés, bars, discotheques, clubs and similar businesses. Bartenders are also known as barman or barkeeper.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbj).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

##### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.
