The Mechanic refrigeration technology assembles, maintains and repairs refrigeration and freezing installations for a whole range of applications and of different dimensions. Refrigeration and freezing installations in shops, restaurants, warehouses, on (refrigerated) vessels and in industrial companies that manufacture products susceptible to decay such as the dairy industry and meat industry. These installations must comply with strict standards and reguirements, in particular in respect of the environment.

A candidate qualifies for the certificate after having passed the following modular qualifications Social and cultural education

Inspection and maintenance refrigeration technology

Assembly refrigeration technology

Preassembly refrigeration technology

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.
