3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Sales specialist fashion are:

Core task 1: Is responsible for the receipt and processing of goods

- 1.1 Manages colleagues on receipt and in processing of goods
- 1.2 Supervises colleagues on receipt and in processing of goods
- 1.3 Is responsible for receipt of goods
- 1.4 Is responsible for storing away goods
- 1.5 Takes care of audiovisual merchandising
- 1.6 Inspects the stock and orders (or suggests what to order)
- 1.7 Takes care of sales area and/or storage area

Core task 2: Sells, gives advice and service

- 2.1 Manages colleagues in their sales activities
- 2.2 Supervises colleagues in their sales activities
- 2.3 Receives and addresses clients
- 2.4 Carries out sales and advisory consultations
- 2.5 Supplies made-to-measure work specific to the sector
- 2.6 Prepares entertainment duties
- 2.7 Places an order on behalf of a client
- 2.8 Takes complaints and/or deals with complaints

Core task 3: Conducts and/or completes sales transactions

- 3.1 Manages colleagues in the sales department
- 3.2 Makes the payment system ready for use
- 3.3 Provides the client with information about the completion of sale
- 3.4 Runs the payment system
- 3.5 Closes up the payment system and takes care of its administration

Core task 4: Optimises sales and assortment

- 4.1 Suggests improvements concerning the assortment
- 4.2 Suggests improvements concerning the presentations
- 4.3 Analyses the sales figures and makes suggestions for improvements

International agreements The profession of Sales specialist fashion is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
