The most important duties of a Graphic designer are:

A Graphic designer develops concepts, designs, presents, draws up, and prepares graphic material as means of communication. A Graphic designer independently plans work load on the basis of planning and supply of material. A Graphic designer must be able to deal empathically with customers and must possess creativity and a feeling for quality and technical insight. Necessary skills for this profession: drawing- and industrial art skills, overview of the whole graphic-technical production process, insight in the sector of communication industry, and accuracy and presentation skills. Furthermore skills involving project management, dealing with customers, advanced computers skills, and knowledge of the world of communication are required.

The Graphic designer mainly works in graphical enterprises and/or enterprises in the advertisement branch.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
Average duration of the education/ training leading to the certificate	4 year(s) (6400 study hours) (depending on previous education)
<p>Entry requirements</p> <p>The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
