- 1.2 Formulates and edits texts and performs lay-out
- 1.3 Prepares texts for distribution

Core task 2: Arranges meetings

- 2.1 Reserves meeting locations and facilities
- 2.2 Invites participants and provides them with information before, during and after the meeting
- 2.4 Receives visitors
- 2.5 Handles simple financial matters

Core task 3: Handles the mail and the archives

- 3.1 Handles the incoming mail
- 3.2 Handles the outgoing mail
- 3.3 Manages the archives and keeps them up-to-date
- 3.4 Creates and manages files

### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Legal secretaries work in job organizations (large, small, profit, non-profit) that consist of a department and a manager.

#### Access to next level of education/professions

With the certificate of Legal secretary, transfer is possible to a middle management or specialist course (qualification level 4).

A Legal secretary can become an executive secretary, management assistant to a lawyer or notary, notarial legal assistant (clerk) or office manager.

## International agreements

The profession of Legal secretary is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

## Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93231 The education and training for this qualification is offered as of August 1, 2008.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

# **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
