The most important duties of a Medical pedicurist are:

Core task 1: Carry out foot treatment

- 1.1 Make appointments and prepare the treatment
- 1.2 Carry out anamnesis and foot research
- 1.3 Screen and specific research of the possible risk foot
- 1.4 Carries out basic treatment
- 1.5 Gives treatment to (potential) risk foot
- 1.6 Applies pressure distribution techniques
- 1.7 Manufacture and apply orthosis
- 1.8 Applies nail techniques
- 1.9 Provides information and advice and sells products
- 1.10 Evaluates and finishes off treatment

Core task 2: Prepare for independent entrepreneurship

- 2.1 Analyses the market
- 2.2 Shapes the business
- 2.3 Profiles and promotes the business
- 2.4 Purchases and monitors the stock
- 2.5 Arranging the financial part of the (start of the) company
- 2.6 Evaluates the business

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Medical pedicurists work in the personal care industry in the feet care sector. Medical pedicurists can work in the following environments: business at home, ambulatory, hospital, medical centre, or care institute. The most usual working environment is the business at home. The Medical pedicurist increasingly works together with other professionals in, for instance, a multi-disciplinary foot team or diabetes centre.

<p>Access to next level of education/professions The Medical pedicurist can within its own field develop herself even further in terms of additional and specialist treatments and in working in a multi-disciplinary foot team. Development is possible to positions such as: educational instructor, manager, assessor or (commercial) positions with companies for foot care materials and foot care products. Transfer to other paramedic courses at hbo level is also possible to courses such as Podo therapist, skin therapy and Physiotherapy.</p>	<p>International agreements The profession of Medical pedicurist is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>4 years (6400 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
