3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Department manager household goods are:

A Department manager household goods performs executive and management tasks related to the sales process from the interior decorating branch. A Department manager household goods advises customers on (combinations of) product groups. He/she manages the stock, is responsible for professional activities like drafting quotations and communicates with customers about the final settlements. A Department manager household goods has a functional responsibility for the execution of the work activities and has a hierarchical responsibility. He directs, guides and controls the activities of the sales persons.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

- Department manager household goods in interior design or home upholstery;
- Advisor interiors;
- Sales specialist interiors;
- Interior decorating advisor.

5. OFFICIAL BASIS OF THE CERTIFICATE

With a diploma at qualification level 4, transfer is possible to higher professional education.

The profession Department manager household goods of is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
