## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Facility services provider are:

At middle management level, you learn everything you need to know and be able to do for managerial and operational tasks in facility services for organisations. For example you will learn all the necessary skills for catering services, building service and maintenance, financial and general management and logistics. During the course of studies you can follow one of two options: building management (planning, organising and implementing maintenance and cleaning work) or food service management (cooking, serving, planning and purchasing).

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

As a Facility services provider, you may be employed in operational and management work in facility services for organisations such as a hospital, care home, nursing home, large business, conference location, maintenance and cleaning company, company canteen or in the hotel, restaurant and catering sector.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

**4 year(s) (6400 study hours) (depending on previous education)**

##### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
