3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Workshop manager damage repair are:

Core task 1: Supervises the workplace

- 1.1 Plans and divides up the working duties
- 1.2 Supervises and manages workplace colleagues
- 1.3 Is responsible for providing information and the development of workplace colleagues
- 1.4 Monitors and evaluates processes and procedures in the workplace
- 1.5 Makes or assesses suggestions for investments, training or improvements
- 1.6 Carries out (joint) performance and assessment interviews with workplace colleagues
- 1.7 Is (jointly) responsible for recruitment, selection and sacking of workplace colleagues

Core task 2: Carries out working duties for the workplace

- 2.1 Analyses the (client) assignment
- 2.2 Identifies and deals with complaints
- 2.3 Maintains external contacts

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Workshop manager damage repair works as a supervisor at large or smaller passenger car companies such as dealers, universal or quick stop companies from the mobility branche. He carries out inspection, maintenance, repairs, assembly, and diagnosis work on passenger's cars.

Other possible educational programmes can be found in post senior secondary vocational education and/or the higher vocational education. Tangible examples for this are the (technical) business economy and/or management programmes.	International agreements The profession of Workshop manager damage repair is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.														
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93383 The education and training for this qualification is offered as of August 1, 2009.															

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
Average duration of the education/ training leading to the certificate	4 year(s) (6400 study hours) (depending on previous education)
Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
