The most important duties of a Mechanic heavy current installations are:

- Installation of pipe installations in house, commercial and industrial building;
- Installation of cable installations in house, commercial and industrial building;
- Assembly, wiring and installation of switching and distribution devices in house, commercial and industrial building.

A Mechanic heavy current installations is responsible for the execution of his/her own set of tasks that consists of the application of automated routines and standard procedures. Due to changing work situations, drafting and combining of standard procedures and devising of procedures are also part of his/her set of tasks. A Mechanic at this level doesn't bear hierarchical responsibilities.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate 2 year(s) (3200 study hours) (depending on previous education)

# **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.
