- 1.8 Clears up the workplace
- 1.9 Carries out simple maintenance

Core task 2: Supervises wood processing machine operators

- 2.1 Supervises and instructs
- 2.2 Monitors progress and quality
- 2.3 Reports to supervisor

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round machine operator wood working CNC furniture industry (level 3) works for wood-processing companies who process various types of wood and sheet materials using machines. These can be companies in the timber or furniture industry, or wood industry.

Access to next level of education/professions

The most logical step for the All-round machine operator wood working CNC furniture industry is to become an assistant manager or planning officer (level 4). Another career opportunity for the All-round machine operator wood working CNC furniture industry (level 3) is to broaden his working area by switching to an adjacent sector.

International agreements

The profession of All-round machine operator wood working CNC furniture industry (level 3) is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93535 The education and training for this qualification is offered as of August 1, 2009.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
